I am writing to support the proposed rules on stock option expensing. Options aren't free money. Simply put, options are a form of non-cash compensation with value to the recipient and a cost to the company. The failure to expense stock options distorts reported earnings, leads to excessive executive compensation, and gives executives incentive to manage numbers for short-term gain.
