Dear Board Members and FASB Staff:

The Mortgage Bankers Association¹ (MBA) will be sending a more comprehensive comment letter on the Proposed Accounting Standards Update, Receivables, Clarifications to Accounting for Troubled Debt Restructurings (TDRs) (Proposed Update) in several weeks. In consideration of the timing of the Proposed Update comment and review period, MBA requests that FASB consider delaying the new TDRrelated disclosures in the Accounting Standards Update No. 2010-20, Disclosures about the Credit Quality of Financing Receivables and the Allowance for Credit Losses (ASU 2010-20) until FASB has completed its due diligence on the Proposed Update and issued any new guidance.

ASU 2010-20 will require significant new disclosures with respect to TDRs. For public entities, the new disclosures are effective for interim and annual reporting periods ending on or after December 15, 2010. Disclosures about activity occurring during a reporting period are effective for interim and annual reporting periods beginning on or after December 15, 2010. These effective dates occur before the proposed effective date of the Proposed Update which possibly changes the definition of a TDR.
