This e-mail is regarding FASB draft stating that they intend to treat stock options as an expense. Sir, i would like to convey my personal opinion about that. This wuld harm employee motivation and the global competitiveness of cisco. These stock options are real motivating factor for us to work hard and deliver. ot only it benefits us and our family it benefits our shareholders as well. Some of the key issues i see:

1. The artificially high valuation for a stock option required by FASB will eliminate stock options as a tool which has driven innovation and productivity in cisco.

2.Stock options do not meet the definition of an expense because they do not use company assets.

3.The true cost of a stock option is dilution of earnings per share (EPS) and is already accounted for when options are exercised.

4. We need stock options for cisco to compete globally. For example chineese and indian high tech companies have employee stock option and they do not treat them as an expense.

5. Expensing stock options could have a dramatic impact on American high tech leadership, innovation and job creation.
