## Type of Document and Timing Based on the Technical Plan:

The Board met to discuss issues relating to the development of an Exposure Draft addressing Financial Statement Presentation.

The Board has not yet determined the timing of the release of that Exposure Draft; however, an Exposure Draft will not be published in the first quarter of 2011 as previously planned.

## **Summary of Decisions Reached:**

At the October joint meeting, the staff updated the Boards on their outreach activities related to the July 2010 staff draft of an Exposure Draft on financial statement presentation. The Boards discussed how to proceed with the project.

## Next Steps

The staff and Board advisors will meet with the project working groups in December 2010 to discuss the cost and benefit information received during outreach activities and possible ways to move forward. The Boards will return to this project when they have the requisite capacity. This is expected to be after June 2011.

<u>General Announcements</u>: The Boards acknowledged that they do not currently have the capacity to devote the time necessary to consider information learned during outreach activities and modify their tentative decisions. Consequently, the Boards decided to not issue an Exposure Draft in the first quarter 2011 as originally planned.
